This Release and Waiver of Liability, executed on ______, 2019, by ______ ("SVTR Rider") releases di Rosa Preserve (DBA di Rosa Center for Contemporary Art) and the Rene & Veronica di Rosa Foundation, a non-profit corporation organized and existing under the laws of the State of California, and each of its directors, officers, employees, and agents (collectively, "di Rosa"), and Sonoma Valley Trail Rides (SVTR), from liability for any risks he/she/they may encounter or may arise in the context of the Activity identified above ("Waiver and Release").

SVTR Rider understands that di Rosa is located on 217 acres in the Carneros region of the Napa Valley. The property includes three separate galleries, a sculpture park, a 35-acre lake, and a wildlife preserve. SVTR Rider understands that he/she/they must be comfortable with and enjoy nature, including native waterfowl and domestic peacocks that roam freely on the grounds.

In consideration for permission to engage in the Activity, I hereby state the following:

1. <u>Assumption of Risk</u>. I certify that I am physically fit, have sufficiently prepared for participation in the Activity and have not been advised to not participate in it by any medical professional. I acknowledge that the risks related to this Activity may include but are not limited to those caused by the terrain, facilities, temperature, weather, wildlife, equipment and actions of other people involved in the Activity. I hereby assume all of the risks of participation in the Activity, including, by way of example and not limitation, any risks that may arise from the negligence or carelessness on the part of SVTR, di Rosa or their employees or agents, as well as from dangerous or defective equipment or property owned, maintained or controlled by SVTR or di Rosa, or because of SVTR's or di Rosa's potential liability without fault. 2. <u>Waiver and Release</u>. I know that this Waiver and Release will be relied upon by SVTR and di Rosa and will govern my actions and responsibilities during the Activity. I hereby waive, release and forever discharge and hold harmless SVTR and di Rosa, its employees and agents, and its successors and assigns, from any and all liability, claims and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from any the Activity with SVTR and di Rosa or related to the Activity. I understand and acknowledge that this release discharges SVTR and di Rosa from any liability or claim that I may have against SVTR or di Rosa with respect to bodily injury, personal injury, illness, emotional distress, death or property damage that may result from the Activity or occurring while I am engaged in this Activity. I understand and agree that this Waiver and Release of liability shall be construed broadly to

provide a release and waiver to the maximum extent permissible under applicable law. Initial here: ____

3. <u>Insurance</u>. I understand that neither SVTR or di Rosa assumes any responsibility for or obligation to provide me with financial or any other assistance, including but not limited to medical, health or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of SVTR or di Rosa beyond what may be offered freely by SVTR or di Rosa in the event of injury or medical expenses incurred by me.

4. <u>Medical Treatment</u>. I hereby release and forever discharge SVTR and di Rosa from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during the Activity.

5. <u>Photographic Release</u>: I hereby grant and convey to SVTR and di Rosa all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my likeness or voice made by SVTR or di Rosa in connection with the Activity.

I certify that I have read this document and I fully understand its content. I am aware this is a contract that releases SVTR and di Rosa from any and all liability to me.
